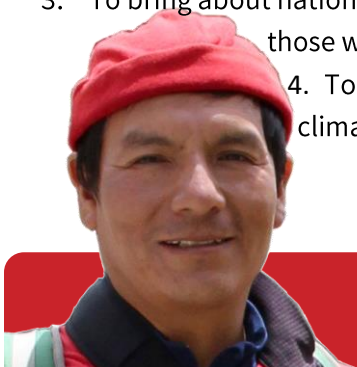
The case of Huaraz points to the major responsibility of large energy companies

STATUS QUO

- The Peruvian farmer and mountain guide Saúl Luciano Lliuya has filed a lawsuit against RWE. Due to climate-change induced glacial retreat, a devastating flood disaster threatens Saúl's house and large parts of the Andean city of Huaraz where up to 50,000 people could be affected.
- The energy company RWE, the largest CO₂ emitter in Europe, is responsible for about one half percent of all industrial greenhouse gas emissions since the beginning of industrialisation. Saúl Luciano Lliuya demands that the company pays 0.5% of the costs for the necessary protection measures in Peru.
- This legal case is the first of its kind in European courts. It has already been an important step towards new legal mechanisms for people affected by climate change as leverage for political solutions.
- 24.11.2015: Saúl Luciano Lliuya files the lawsuit, which is classified by the District Court Essen as "a legal matter with fundamental significance".
- June 2016: In its statement of defence, RWE disputes its own responsibility for climate change induced damage in the Andes and denies that Huaraz even faces a risk of flooding despite warnings from international scientists.
- 24.11.2016: The first oral hearing takes place amid great national and international interest – the decision was adjourned.
- 15.12.2016: The District Court Essen dismisses the civil lawsuit against RWE. However, the legal dispute is not over:
- 26.01.2017: Saúl Luciano Lliuya files an appeal before the Higher Regional Court Hamm against the negative ruling of the Regional Court Essen. The reasons for dismissing the lawsuit are wrong in the opinion of Saúl's lawyer Roda Verheyen. The Court's ruling disregards facts that were brought forward and alleges a general lack of legal causality. Verheyen views such a legal causality as established. The fact that multiple polluters are contributing to climate change impacts does not absolve individual polluters of responsibility. If necessary, Saúl Luciano wants to take his case to the highest court.
- 13.11.2017: Parallel to the political negotiations at the UN Climate Summit in Bonn, the 5th Civil Chamber of the Higher District Court Hamm has scheduled an oral hearing for the appeal of Saúl Luciano Lliuya.

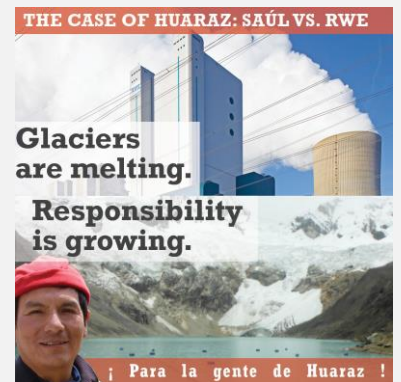
OBJECTIVES OF THE LAWSUIT

1. To hold polluters like RWE accountable and incite them to shift to less damaging business models.
2. To support the claimant and citizens of Huaraz in reducing the risk of a disastrous flood.
3. To bring about national and international political solutions for protecting those who are most vulnerable to climate change.
4. To develop new legal mechanisms for people affected by climate change – as leverage for political solutions.
